Chris Giattina is president of Giattina Aycock Architecture Studio, a fifty-person design firm well known for creating elegant solutions to complex problems. Under his leadership, GA Studio's work has been consistently recognized for excellence at the local, state and national levels. Their current clients include Children's Health System, BellSouth, Protective Life, Alabama Power, Blue Cross Blue Shield, Birmingham Civil Rights Institute, and the Railroad Park Foundation.

Chris received his architectural education from the University of Pennsylvania, the Georgia Institute of Technology and the Ecole Des Beaux Arts in Paris, France. He serves as an adjunct professor for Auburn University's Urban Studio and is a frequent jury critic for Illinois Institute of Technology and Georgia Tech. In addition to running a practice and teaching, Chris's long-time interest in sustainable systems has contributed to a body of work that has earned him a reputation as an expert in the field. His recent work includes leadership of national teams of experts conducting sustainability assessments for Syracuse, New York and New Orleans, Louisiana and a sustainability lecture series that has been highlighted by Green Building Focus and the American Institute of Architects.

Chris is a native of Birmingham where he lives with his wife Ingrid, a veterinary cardiologist, German national and the mother of his four children: Sophia, Henry, Constantine and Giuseppe.
